Big plans for corner of Broadway

\$14 million project adds retail, apartments

A \$14 million project proposed for downtown Alexandria would completely change the look of the 300 block of Broadway.

The project includes a building foot-print of 37,200 square feet and would replace vacant buildings that last housed Bello Cucina restaurant and Blue Collar Bob's.

The new four-story complex would consist of commercial and retail space - including a new, unnamed restaurant — along with 75 apartments, ranging from studios to one- and two-bedroom units, according to the developer, Good-Neighbor Properties, LLC, represented by Rob Thompson and Ted Christianson. It would also include 162 parking stalls, 112 of them underground.

Plans for the property were discussed at Monday night's Alexandria City Council meeting.

The developer is applying for tax increment financing to help pay for the project. With TIF, property taxes are frozen at the current rate for several years, and the future tax savings are used to help cover site development costs.

The developer is requesting to receive \$3.5 million in TIF over a 13-year period.

The council didn't take action on the request but scheduled a public hearing for Monday, Feb. 25, at 7 p.m.

If approved, the project could start in March and be completed by June 2020.

In its TIF application, GoodNeighboi Properties noted the development would be located on the busiest intersection in Alexandria and would replace buildings that are in bad shape and beyond their useful life.

"The existing businesses on these lots have struggled and changed hands multiple times over the past 10 years," the application noted. "This project will clean up the corner and provide a facility that will be something more representative with the long-range goals of the city."

The developer said TIF is needed to make the project financially feasible because of the high cost of acquiring the properties, demolishing buildings and developing the site.

The rental rates for the apartments haven't been calculated yet, but are expected to range between \$1,200 and \$2,500 a month, slightly above the standard market, according to the developer.

The Alexandria Planning Commission tabled GoodNeighbor Properties' request for a planned unit development at its Nov. 19 meeting. It asked several questions about parking and wanted more time to digest the details of the project.

No one hurt in drive-by shooting

No one was injured when a half-dozen gunshots were fired into a house and garage shortly before midnight Friday, Nov. 23, in Hudson Township, southeast of Alexandria.

According to the Douglas County Sheriff's Office, a caller reported hearing several gunshots and a vehicle leaving the area near County Road 17 and County Road 31, northeast of Forada and southwest of Nelson, traveling northbound at a high rate

of speed.

When deputies responded to the residence they believed was involved in the shooting, at 5951 County Road 17 SE, they found two individuals outside the home who stated that someone had just shot up their house.

While searching the area, deputies found one 9mm shell casing on County Road 17. Deputies returned the next day and searched the area again in daylight, finding three more shell casings and six bullet holes in a garage and the residence.

It was determined that the shots came from County Road 17.

The evidence was collected and will be processed by the Minnesota Bureau of Criminal Apprehension in St. Paul.

According to the sheriff's office, this was not a random incident and there is no ongoing threat to the general public.


