Ebnet, who moved to the neighborhood in December, said he saw police officers come down the street earlier that morning. He then went for a run.

"I was gone for about 45 minutes or so," said Ebnet. When he got back, he was told he could not get into his house because of an active shooter situation.

"This just goes to show you no matter where you live, anything can happen," Ebnet said.

Another neighbor, Brandon Schindler, 26, said he was sleeping when other officers began arriving on scene. Officers told Schindler and Katelynn Cheadle, 22, that they needed to "get in the basement or evacuate."

Schindler and Cheadle left and went a few blocks away, they said. "You just don't see stuff like that in Sauk Centre," Schindler said.

Cheadle also said she knew the neighbor who lived in the house where the incident took place, and the pair said it was a "crazy" situation.

The answer to the complaint also asks the court to dismiss the complaint without prejudice, declare the city fully complied with all legal requirements concerning the sale and award the city its costs and reasonable attorney's fees.

St. Cloud Mayor Dave Kleis said Wednesday the city went through a very public and transparent process with the Heritage Park sale.

The complaint states Citizens for Government Accountability is made up of citizens who "reside in or own taxable property in the city of St. Cloud," but does not disclose the members of the group or

"It's unfortunate the lawsuit is anonymous," Kleis said. "We believe it has no merit."
