Cirrus level of service

Duluth-based Cirrus Aircraft rolled out its new jet ownership program last week.

On the heels of the success of its Vision Jet — which was the best selling general aviation jet earlier this year — the new program gives Cirrus aircraft owners everything they need to own and operate their aircraft.

VisionAir's services include an on-demand professional pilot, concierge services, maintenance coverage, aircraft management oversight and storage, as well as options for insurance coverage and referrals for tax advice. The VisionAir program, a news release said, improves privacy and ensures a "world-class experience."

"Now, new Vision Jet owners can simply arrive and fly," Cirrus CEO Zean Nielsen said in the release.

Paycheck program protects jobs

The paycheck protection program retained nearly 60,000 jobs in Northeastern Minnesota, according to an analysis by Carson Gorecki, DEED's regional labor market analyst for Northeastern Minnesota.

federal government's Coronavirus Aid, Relief, and Economic Security Act, PPP provides forgivable loans that can cover up to eight weeks of payroll.

The approximately 60,000 jobs retained in the region were spread across more than 4,400 companies, according to the analysis.

When looking at distributed PPP loans by industry in our area, you'll see that the construction industry received the highest number of loans. Retail trade was second, followed by the other services except public administration industry. Even though they received the largest number of loans, these industries didn't retain the highest number of jobs, according to the analysis.

That title goes to the health care and social assistance industry as well the accommodation and food services industry, which retained over 12,700 and more than 10,800 jobs, respectively.

These loans ranged anywhere from less

than \$5,000, up to \$10 million. But only a few dozen businesses received more than a \$1-million loan in both rounds of PPP disbursement.
