## Wet fall delays harvest

ktolkkinen@echopress.com Ken Marthaler would have

preferred to be in the fields on Tuesday, combining soybeans. Instead, he was perusing farm equipment for an upcoming retirement auction.

The fall harvest is proving "slow, muddy, wet," said Marthaler, who runs a 60-cow dairy in Osakis and grows corn Karen Tolkkinen / Echo Press for feed and soybeans as a cash

Local farmers are contending with a late spring, a cool summer, and a run of low commodity prices, said Russ Elliott, president of the Douglas County Corn and Soybean Growers Association. A cool, wet fall and a predicted early snowfall and freeze, he said, are "adding insult to injury."

Their pain is felt across the state. Typically, about 43% of soybeans would be harvested by now in Minnesota, according to **HARVEST:** Page A11

the National Agricultural Statistics Service. This year, that figure is at only 8%.

September created fields that were much squishier than last year. In September 2018, Chandler Field airport in Alexandria logged 1.26 inches of rain, according to the Old Farmers Almanac, which tracks rainfall at sites across the country. This year, September delivered 6.57 inches of rain to the airport.

# PUTTING THE FOCUS ON CHILD ABUSE

### Authorities look into hundreds of cases a year

lmost 140 children - infants on up to age 17 – were served by Someplace Safe in Douglas County during its last fiscal

As of Sept. 1, Douglas County Child Protection Services had received 508 reports of possible child abuse in 2019. Of those, nearly half - 44 percent - had enough information/ evidence to warrant an investigation.

In all of 2018, Douglas County Social Services received 808 reports, with 340 (42 percent) having enough information/evidence to warrant an investigation.

Child abuse, whether physical, emotional, sexual or neglect, is prevelent in this area and is the focus of this year's annual Domestic Violence Awareness Month events hosted in part by Someplace Safe in Douglas County.

## **Broadway** project gets grant

### Developer gives details on timeline

A \$14 million project that will completely change the look of the heart of Alexandria's Broadway received a \$350,000 boost this week.

The Minnesota Department of Employment and Economic Development announced Tuesday, Oct. 8, that it has awarded the grant to help redevelop a 2.3-acre spot on Broadway and Third Avenue previously occupied by Blue Collar Bob's and Bello Cucina restaurant.

The money for the Alexandria Economic Development Authority will come from the state's Redevelopment Grant funds and go toward demolition and infrastructure improvements, led by developer GoodNeighbor Properties,

This site will be redeveloped to a four-story, mixed-use building offering 23,450 square feet of retail and professional space, 75 apartments and

one level of underground parking.

The state said this project is anticipated to create 37 jobs and increase the tax base by \$209,847. Matching funds will be provided by tax increment financing and the developer.

Mike Weber, Alexandria's city plan-ner, said the grant was "exciting news" and credited Nicole Fernholz, director of the Alexandria Area Economic Development Commission, for writing the grant application.

At one time, the project was expected to start in April, but it has encountered delays. Weber said that although there's been "no shovel in the sand yet," the developer has until Dec. 31, 2020 to have the building substantially complete under the terms of the tax increment financing agreement with the city. The developer could also file for an extension if needed.
