LF Council to propose project to Legislature for

The Little Falls City Council voted Tuesday to pass a resolution allowing the city to submit a proposal to the State Legislature seeking approval to add a local option sales tax to the ballot for the No- 10 acres of the 14-acre parcel of vember 2020 election.

The city is looking to build a community recreation center the educational components of which is proposed to have a multipurpose gym with an indoor track, spaces as well as outdoor recreation amenities. The facility may also house a child care center.

If the Legislature approves the plan, City Administrator Jon Radermacher said that residents will be able to vote on a proposed local sales tax of .5% per year for 30 years, generating \$17 million to fund the facility. A .5% inflation on the revenue generation is figured into the total.

Foster care and adoption on the rise in Morrison County

For the last 15 years, as drug addiction become more prevalent in Morrison County, the number of children placed in foster care statistics, so we don't have an ac- reunite. There is always a lot of and adoption has increased.

Melanie Erickson, Morrison County Social Services supervisor, said in 2000 the number of children in foster care was 34. In 2005, it jumped to 91.

"The move to more than 90 children occurred first in 2005, due to the first round of meth addictions. There has been a pretty steady increase since then," she said. "We've never had this many kids in foster care. A lot of it is due to the significant drug problem we have in the county with heroin and meth and kids not being in safe situations."

In 2019, 116 children in Morrison County were placed in foster care. But the real number of children who are affected by parents' drug addiction, incarceration, mental illness or other circumstances that keeps them from providing a safe environment, is much higher than that.

Kids who need mental health services have options

Upward of 20% of the youth worldwide experience a mental disorder, with half of all mental illnesses beginning by age 14, according to the World Health Organization (WHO).

Treating a mental illness is unique to every individual, and is often difficult for children due to a lack of funding and resources. Some team members with the County's Children's Mental Health (CMH) program said these barriers definitely exist, but kids still have treatment options.

The CMH program is a voluntary, free of charge, service for qualifying county residents under 21 who need education, support or coordination of mental health programs.
