County to vote on welcoming refugees

The Winona County Board will hold a public hearing late this month before deciding whether to opt in to accept refugees under a federal refugee resettlement program. A recent executive order from Pres-

ident Donald Trump requires both states and counties to opt in in order to officially host incoming refugees and receive federal funding for resettlement programs.

Refugees are people fleeing violence or persecution in their home countries. Under federal law, to claim asylum and be accepted into the U.S., refugees must demonstrate "a well-founded fear of persecution on account of race, religion, nationality, membership in a particular social group, or political opinion." Minnesota has long welcomed refugees from the civil war in Somalia and Hmong people who faced repri-

sals for fighting on the side of Americans during the Vietnam War, for example.

In response to the executive order, Minnesota Governor Tim Walz affirmed that the state government wants to receive refugees.

St. Matthew's celebrates a century

With influences from people who immigrated to the U.S., a number of pastors and a school, Saint Matthew's Evangelical Lutheran Church has many aspects that compose its 100-year-long history. To mark the 100th anniversary of the organization of the church, St. Matthew's will hold several special services throughout this year.

Worship services on January 4 and 5 celebrated the anniversary, and it will also be marked with worship services on June 6 and 7 and December 5 and 6. A heritage hymn sing will take place on September 19 and 20 as well. The annual candlelight service, which recognizes the dedication of the church, will be held on December 6.

St. Matthew's is a daughter congregation of Saint Martin's Evangelical Lutheran Church, which is on the East End of Winona.

In the late 19th and early 20th centuries, people immigrated to Winona from Germany. Those who were Lutheran formed churches for themselves, and St. Martin's was the first such church in Winona, St. Matthew's member and unofficial church historian John Berg said.

St. Martin's had grown a great deal by the World War I era, Berg shared, and in 1919, it voted to allow around 160 of its members to begin a new congregation

The Upper Mississippi River National Wildlife and Fish Refuge, which is one of the biggest sections of floodplain habitat in the contiguous U.S. and features soaring bluffs and a wide river valley, is highly active during winter. A couple hundred people and a jazz band crowded the foyer last Saturday as local leaders cut the ribbon on the new Wanek Center, a \$20-million school-and-community gymnasium, recreation center, and library in Arcadia.

Years in the making, the expansive facility provides a space for Arcadia children, adults, and families to play, exercise, gather, and learn. The middle and high school will share the new gym and workout facilities with the public — who can buy memberships to the gym — and by the end of the month, the city of Arcadia Public Library will move into its new home at the center. School District of Arcadia Superintendent Lance Bagstad called its opening a "defining moment in our community's history."

"Today is a great day for Arcadia," School Board President Paul Servais stated. "It's a great day for our schools. It's a great day for our community. I'm going to be honest with you, when I walked up the steps and I looked upstairs, I was like 'Am I still in Argadia?'"
