Times criticizing changes to the public comment procedure at council meetings. The change made earlier this year moved the public comment period to the end of the meeting, where it is not broadcast nor included in meeting minutes.

Some members said writing the letter was a violation of the council's rules of conduct because they said it undermined a majority vote of the

"We urge the city council to immediately amend its rules and rescind the censure of (Hontos)," states the letter written by David P. McKinney, staff attorney for the ACLU. "Specifically, we believe that rules six, seven, and eight appear to violate the First Amendment in that they broadly prohibit a substantial amount of protected speech."

The ACLU sent a formal letter

ST. CLOUD — Philosophy of science is an important field right now, considering things like the anti-vaccination movement, said St. Cloud State University philosophy professor Michael Shaffer.

Shaffer specializes in the philosophy of science, the consideration of

how science works and how the public digests it. He has been published and lauded for his work around the world.

Yet Shaffer's time at St. Cloud State is drawing to a close, as he's on a list of eight professors to be laid off at the end of the academic year.

He's taught classes called Evidence and Pseudoscience, Business Ethics

More than 35,000 could lose food stamp access

Nonprofit leaders are pushing back on a federal proposal to change who's eligible for food stamps that could cause 35,500 Minnesotans to lose access to food assistance.

On Thursday, food shelf leaders and others voiced opposition to the rule change for the Supplemental Nutrition Assistance Program (SNAP), commonly referred to as food stamps, ahead of Monday's deadline for public input.
