### **CBP** seizes \$4.5M of pot at Pembina Port of Entry

**PEMBINA,** N.D. — U.S. and Border Customs Protection (CBP) Office of Field Operations officers at the Pembina Port of Entry targeted a commercial shipment that had arrived in Pembina on Friday, April 23. CBP officers inspected the shipment manifested as straw to discover 2,796 pounds of marijuana within the shipment.

"Customs and Border Protection has a multi-layer enforcement posture, with the thoroughness performed by the Primary officer being phenomenal, which led to the referral of the truck. Utilizing our available technology led to further examination of the shipment," said Pembina Area Port Director Jason Schmelz. "This interdiction keeps narcotics from entering the United States and reinforces the important border security mission CBP officers have in keeping our country and communities safe. The teamwork involved in a seizure this large was outstanding.

Homeland Security Investigations and Pembina County Sheriff's Department were contacted and responded to assist.

#### **Spring load restrictions lift May 3** for North, North Central zones

Minnesota The Department Transportation will end spring load restrictions in

the north central and north frost zones Monday, May 3 at 12:01 a.m. Spring load restrictions have already ended in the

other frost zones. Frost zones and restricted routes can be found on the MnDOT load limits

map.
Start and end dates and

other load limit information are shown at mndot.gov/ loadlimits.

Overweight permits for more than 80,000 pound gross vehicle weight continduring spring load restrictions and new permits will be issued if all axle and group weights are legal (axle weight limits).

Full-summer overweight permits can be issued, during the spring load restriction period, for travel on the interstate system only.

Middle-range overweight permits become available within each frost zone when spring load restrictions are lifted. Full-summer overweight permits become available two to three weeks after spring load restrictions are lifted.

Ending dates for spring load restrictions are variable and based on how weather is affecting roadway strength. For questions about legal
