This year, both Editor Margie Holmgren and Reporter Anna Jauhola won prizes for their efforts.


Holmgren took third place in Best Advertisement for non-daily newspapers with circulation up to 1,500. Her ad portrayed the End of an Era Retirement Sale for Anderson Country Collectibles.

"It's an honor to win this award as I know I am competing with a lot of great entrants," Holmgren said. "Creating ads and documents that are eye catching is just one of the things I enjoy about my job. # **County hires DDA Human** Resources to find an engineer

Nearly a year ago, Kittson County began searching for a new county engineer. It's been a tough go.

In a last resort effort, the county board of commissioners has decided to hire DDA Human Resources to assist them in finding an engineer. The board met with Gary Weiers, of DDA, in a special meeting on Wednesday, Jan. 27. Weiers assisted the county in hiring a new administrator earlier in 2020.

"This is an incredibly difficult position to fill," Weiers said. "That's really all over the state of Minnesota. This is a significant challenge for counties. The more remote you are, the more challenging it

Current legislation surrounding county engineer positions really poses the most challenge because it restricts counties in who they can hire. Those applying must live in Minnesota and be licensed in the state.

The legislation does not allow flexibility for a county like Kittson, which borders North Dakota and Canada, to allow reciprocity with those nearby willing to com-

Salary range is also an issue from both ends. Kittson County has offered the position to two different applicants within the last several months. One asked for an increased salary but then declined the position. The other didn't counter an offer in the mid-\$90,000 range because he lives in North Dakota. However, Weiers told the board they're not likely to get any other candidates for such a low salary when several counties in the state have increased wages just to keep their engineers.

"I do think the problem is getting acute," Weiers said. He is also conducting an engineer search for Roseau County, which lost its engineer in mid-2020. Roseau is

proposing a salary range of \$115,000 to \$140,000. Kittson County The

board discussed raising its engineer salary range and will have a final decision in February. The board's current salary offering tops out at \$101,000, which Weiers flat-out said would not draw in any applicants. Over the last year, with interim county engineers plus a bump in the assistant county engineer's salary, the county has paid \$165,000. While County State Aid dollars pay the engineer's salary, that allocation does not increase just because a county increases the pay instead the increase takes away from any projects the county can pay for with

State Aid.
"The problem is, if we pay someone \$140,000, how does that affect other people that need to be at that level?" asked Commissioner Theresia Gillie. "This is a lot of money. I know what we pay Dillon (Hayes). And we have people who've worked here a long time. It creates a huge ruffle that goes everywhere.

# **Kittson Healthcare** does not expect COVID vaccine this week

19 vaccine this week are being encouraged to find locations outside Kittson County.

According to its Facebook page, Kittson Healthcare Center in Hallock stated Monday it was not expecting to receive any vaccine this week from Minnesota Department of Health. Officials are uncertain when they may receive vac-

To find other locations, the Minnesota Department of Health has established a website to search for vaccination locations — https:// mn.gov/covid19/vaccine/find -vaccine/.

This will take you to a page where you can click on Find Vaccine Locations. Either you can zoom in on a map of the nearest locations or you can search by city name or ZIP code.

The closest locations to Kittson County to possibly have the vaccine on hand include Crookston, East Grand Forks, Thief River Falls and Warren. To schedule a time with any entity, you must call that location. Thief River Falls hosted a

Pilot Vaccination Clinic last week, which targets those age 65 and older. Due to shifting scheduling and vaccine distribution, there isn't a clinic this week.

Kittson Healthcare is also encouraging people to help take care of each other by assisting elderly family, neighbors or friends to help schedule vaccinations.

Over the last week, Kittson Healthcare vaccinated 110 people in the Priority group 1b, which includes people 65 and older, K-12 staff and daycare providers.

# KCC sports going well, despite challenges

Kittson County Central winter sports have been progressing nicely, despite challenges, since State High Minnesota School League allowed play to begin in early January. Most challenges surround capacity restrictions.
The Kittson Central

School Board discussed the issue at the regular meeting on Wednesday, Jan. 27. Each student has been

limited to two spectators per household at home games and the issue of social distancing versus capacity numbers has been questioned. "In trying to figure out

how home games would work for us in the winter, we put a lot of work into figuring out what our capacity is," said Kittson Central Activities Director Jami Carr. "And we're trying to make sure our community understands what regulations and guidelines we have from the state high school league.'

In the MSHSL's rules for spacing due to COVID-19 restrictions, a clause said the max capacity at any game is 150 people. Carr said that maximum would be just for spectators if they could sit 12 feet or more from the playing surface.

"In our facilities, if we

were to go 12 feet from our playing surfaces, we would use the top two bleachers in the arena and at the school," Carr said. "But that's not maximizing people in.'

Since they can't facilitate that large of a crowd that far from the surfaces, they must also count players, coaches and game personnel in that 150 total.

"Home games, games, every school is doing it a little differently between registration, who's allotted tickets. It's kind of been a moving target," Carr said. "But as we're now in the second week of contests, full week of contests, I think people are kind of starting to get the routine of this new part that COVID has

Carr also commended players and coaches for taking in stride the mandate they wear masks during practice and games. For the most part, players are adhering to mask use and coaches are working with the kids, ensuring mask breaks and water breaks.

"I know it's not easy just wearing one on a regular basis, let alone while working out," Carr said. "The coaches have really helped out in so many ways and I appreciate that.' Continued on page 3
