# Green Wave end regular season with 33-29 win over Panthers

Green Wave football closed out their regular season last Wednesday at the Senior High complex in a 33-29 win over Park Rapids that featured nine touchdowns eight of which were scored on plays of over 20 yards.

"It's was big play after big play," said Green Wave Head Coach Ryan Kasowski. "Offensively we haven't had a lot of those so it was kind of fun."

The Green Wave struck first with a 55 yard pass to Tanner Campos from Sam Votava. Park Rapids answered back with a 49 yard touchdown pass to end the first quarter knotted at 6.

Carter Vasek put the Wave back on top with a 39 yard run. Again Park Rapids answered back capping thier touchdown with take the lead into the half.

The Panthers came out of the break and extended their lead taking advantage of their tall receivers and scored with a 23 yard touchdown pass.

Senior High answered back with scoring runs of 25 and 22 yards from Votava and 41 yards from Vasek to take a 33-21 lead

late in the game.

Park Rapids quickly scored but were forced to hold the Green Wave offense to a three and out series when their on-side kick attempt failed, leaving the Panthers with little time to drive the field.

"I was really proud of our kids. When we went down I didn't know how we were gonna respond and I was really proud of the kids to come back in that game, and make the plays, and do what needs to be done to win and yeah,' says Coach Kasowski. "I am really proud of our seniors. It is the last time they'll play on that field so it was a good way to good way to finish it out.'


