

### Four-run first inning boosts Air Freight ball team over Millers 7-1

### Minnetonka ends season at state

Four runs in the first inning keyed Air Freight Unlimited's 7-1 win over Minnetonka Aug. 21, in the State Class A Amateur Baseball Tournament at Palm Field in St. Anthony Village.

Since the state tourney is single-elimination this year, the loss ended a highly successful Millers' season. Minnetonka's final record for 2021 is 39-10-1.

"We gave them a few runs early," Minnetonka manger Kevin Hoy said, referring to the first inning that included a walk, an error and three Air Freight hits. "We couldn't afford an inning like that."

Freight pitcher, lefthander Graham Laubscher, was sharp throughout the game, hitting corners and not letting the middle of Minnetonka's order beat him. The only run he allowed was a home run by first baseman Jack Hanson, who pulled the ball 370 feet over the left field fence in the top of the ninth. Designated hitter Kyle Hoffman was the only Miller to come up with two hits.

Besides Hanson's home run, the highlight for Minnetonka was six scoreless innings of relief from righthander Ben Hughes, who entered the game in the bottom of the second and left the mound in the bottom of the eighth, when Paul Voelker was called to finish up.

"Air Freight is a good hitting team," Hughes said. "You're not going to get a lot of strikeouts against them. We were not able to have that big inning we needed.'

Hughes, who led the

pitching staff along with Miller veterans Donny Erdall and Brandon Broxey, wasn't able to play for the town team last summer, when he moved to Chicago for work.

'It was a blast to be back with the Millers this year,' Hughes said. "The only bad part is not being able to play for the championship tomorrow. I am looking forward to next season.'

Joe Abellera, the Millers starter at third base, said, "Their pitcher mixed his pitches well and stayed away from the big guys in our lineup. It was kind of a funky season for us. There were some injuries, our college guys had to leave early. As good a team as we are, we're not going to win every game."

From the manager's standpoint, Hoy said, "We had our moments this season, but I didn't have the feeling that this was going to be our year."

One thing that hurt the Millers' chances was an injury to Zack Trygstad, who was batting over .400 with an on-base percentage over .500, when he was sidelined.

Before the season, the Millers lost starting shortstop Jarod Wandersee to one of the collegiate leagues. That necessitated patchwork at the position with Hoffman and veterans Joe Shallenberger and Blaine Rutledge taking turns at short.

"We'll be back next year and hopefully get our swagger back," Hoy said.

One thing Hoy would like is another shot at Air Freight. The Minnetonka manager didn't appreciate some of the banter from Air Freight's dugout.

"I thought there were times when they disre-spected out players," Hoy observed. "It is a credit to our players that we didn't respond to that."

only came from Wayzata, but from other school districts and the State High School League, as well. Activities directors Dan Johnson from Hopkins, Keith Cornell from St. Michael-Albertville and Jummy Barlass from Eden Prairie came to pay their respects

"Jaime is a great colleague and friend," Dan Johnson said. "He is absolutely the best activities director I know.'

activities Minnetonka director Ted Schultz said, 'Jaime did a tremendous job leading the Trojan activities department. Leading one of the largest schools in the state is an extreme

responsibility. Jaime led with professionalism, passion and experience, which enabled him to be a strong advocate for his program. For me personally, seeing Jaime go is hard because we have partnered in so many endeavors. He is a class act, a tireless worker and even a better person.

#### Coaches weigh in

During Sherwood's tenure, he hired many head coaches who led Trojan sports teams to state titles in the last decade - Aaron Berndt in boys track, Jeff Prondzinski in boys tennis, Scott Jackson in volleyball, Mike Schumacher in girls golf, Allan Christopherson in boys golf, Elizabeth Hansen in girls swimming and diving, Mark Popp in boys cross country, Dave Emmans in girls cross country, Bobby DeWitt in baseball, Pat O'Leary in boys hockev. Bryan Schnettler in boys basketball, Larry Myers in Nordic skiing and Lambert Brown in football. The Trojans have won state honors in both forms of dance - jazz and high kick. And don't forget the long string of championship teams coach Signe Hensel has in synchronized swimming.

Wayzata wrestling coach Eric Swensen has yet to win a state team title, but he has revitalized the program with higher expectations and had the Trojans among the top five in the state last season.

Girls track coach Alicia Pierskalla also has a team that is among the state's elite most years.

Wayzata's rich athletic history includes the hallof-fame contributions of former football coach Brad Anderson, who has three state titles, and Tony Peszneker, who is closing in on his 500th victory as girls soccer coach.

Almost all of Wayzata's current head coaches dropped by the party Saturday night, along with several former head coaches who were hired by Sherwood.

Every comment from Wayzata's coaches reflects a deep respect for Sherwood's role in Wayzata's success.

"I was at Wayzata before Jaime became activities director," former basketball coach Phil Ward said. "Over the course of time, we became friends. We even went to a couple of Bruce Springsteen concerts together. Jaime created a pleasant, fun atmosphere in the Wayzata athletic program. We would sit around talking and always supported each other.'

Lori Cade, head coach of the Wayzata girls track team for 26 years and an assistant coach in the program the last four, said, "Jaime always supported the coaches and wanted the best for the kids. If I needed something for the track program, Jaime would take care of it.

Dominic Duenas, Wayzata High's head boys soccer coach, said, "Jaime was a fantastic activities director. He is a true educator, whether he is working with coaches or students. He loves all activities, all of the programs. No disrespect to the other athletic directors, but I feel Jaime is the best there is.

#### Sherwood's motto

My observation as the local sports writer is that Jaime Sherwood always stood for integrity, school pride and fair play.

There is a reason the Minnesota State High School League's board of directors chose him to supervise at State Tournaments throughout his career. The board members realized that he would always follow through with 100 percent effort, enthusiasm and understanding of the protocols.

If there is one motto that sums up Sherwood's career at Wayzata, it is the motto that hangs above the press box at Wayzata High Stadium: "Play Like a Champion

That's not only a motto for high school athletics, but also a model for life.
