Arrest made in fatal shooting of teen in Sioux Falls

SIOUX FALLS, S.D. — A juvenile suspect has been arrested and charged with killing a Sioux Falls high school senior outside a Halloween party in the eastern part of the city on Saturday night, Oct. 31. Police spokesman Sam Clemens said

the case has not been moved to adult court so the suspect's name or charges couldn't be released. He did report that authorities are investigating the shooting as a homicide.

The juvenile is accused of shooting Lincoln High School senior Venance Kitungano, 18, in the head outside the Red Sea Pub about 9:10 p.m. on Saturday. Kitungano was taken to the hospital

and died the next morning. The suspect was arrested Tuesday,

Clemens said. No alcohol was being served at the

party despite it being held at a pub, Clemens said at a news conference.

night, while his margin in Georgia fell from 68,000 to 2,500. Those numbers were expected to continue to move in Biden's favor, with many of the outstanding ballots from areas that typically vote Democratic, including the cities of and Atlanta.

Biden saw his lead in Arizona contract from 93,000 to around 48,000; he was ahead in Nevada by only 11,000

Biden would become the next president by winning Pennsylvania, or by winning two out of the trio of Georgia, Nevada and Arizona. Trump's likeliest path

Most major television networks gave Biden a 253 to 214 lead in

Electoral College votes, which are largely determined by state

population. As demonstrators marched in several U.S. cities for a second straight day, the election lay in the hands of civil

employees who were counting hundreds of thousands of ballots, many of which were sent by mail amid the coronavirus pandemic.

Final results in each state could take days. Pennsylvania Secretary of State Kathy Boockvar said on Thursday afternoon the state still had about 350,000 ballots vet to count.

In Georgia, Gabriel Sterling, an election official, said it would "take time" to process tens of thousands of remaining ballots.

'Messy' democracy

Trump's remarks followed a series of Twitter posts from Trump earlier in the day that called for vote counting to stop, even

though he currently trails Biden in enough states to hand the Democrat the presidency.

Trump's campaign, meanwhile, pursued a flurry of lawsuits in Georgia, Michigan, Nevada and Pennsylvania, though judges in Georgia and Michigan quickly rejected the challenges. Legal experts said the cases had little chance of affecting the electoral outcome.

Biden wrote on Twitter shortly after Trump's White House appearance, "No one is going to take our democracy away from us." In earlier remarks from his hometown of Wilmington, Del., Biden expressed confidence he would win.

"Democracy's sometimes messy," Biden said. "It sometimes requires a little patience as well. But that patience has been rewarded now for more than 240 years in a system of governance that has been the envy of

the world." The close election underscored the nation's deep political divides, while the slow count of millions of mailin ballots served as a reminder of the deadly pandemic that continues

to upend American life. Biden's lead in the national popular vote broke 4 million on Thursday night, though that plays no role in deciding the winner.

assuage the defendants' security concerns but instead is likely to heighten those concerns because the relevant courthouse would certainly be smaller than the Hennepin County Center, Government Cahill said.

The four cers were charged after Floyd, a Black man, died in police custody. They arrested Floyd after a store clerk alleged he was trying to use a counterfeit \$20 bill.

Moving the trial likely would not make a difference, Cahill added.


