Wisconsin men beat, rob man after smoking pot Monticello man left bloodied on Kevin Longley Drive at 4 a.m.

A robbery that left a Monticello man beaten and bloodied has resulted in felony robbery charges against two Wisconsin men.

Devon S. Bernstein, 22 of Cameron, Wisconsin, and Lucas E. Lewis, 33 of Rice Lake, Wisconsin, remained in the Wright County Jail in Buffalo following the September 3 incident. Both men were charged September 7 with first degree aggravated robbery.

Driver four times over limit- with open bottle of vodka in the car

A man who the State Patrol says was driving while his blood-alcohol content was more than four times the legal limit was arrested on Interstate 94 in Monticello on Friday, Sept. 3 after causing an injury accident on the highway.

Mark A. Boedigheimer, 55 of St. Michael, is facing a gross misdemeanor count of criminal vehicular operation causing bodily harm while under the influence and a gross misdemeanor DWI charge following the Sept. 3 incident.

Court records show that Boedigheimer had a blood alcohol content of .325 following the I-94 crash, reported at 11:32 a.m./ in the westbound lane of the interstate just west of Highway 25 in Monticello. According to a criminal complaint filed in Wright County District Court, state troopers arrived on scene to find two vehicles in construction lanes that were closed to traffic. Boedigheimer had hit a vehicle, causing heaving rear-end damage to the vehicle. Troopers noted that Boedigheimer was lethargic and not responding appropriately to questions. Boedigheimer denied being involved in the crash despite his vehicle having significant damage and smoking coming from it. An open bottle of vodka was in Boedigheimer's vehicle, according to the criminal complaint. The victim in the vehicle allegedly hit by Boedigheimer suffered bodily harm as a result of the crash, including neck and back injuries. Boedigheimer has two prior DWI convictions, according to court records.

Man dies in I-94 semi crash

A Wisconsin man was killed in a one-vehicle crash on Interstate 94 west of Monticello Monday, Sept. 13.

The crash occurred at 8:50 p.m. at mile post 186about three miles west of Monticello in Silver Creek Township.

The Minnesota State Patrol reports that Ronald W. Biggerstaff, 53 of Antigo, Wisconsin, was the victim in the crash.

Biggerstaff was driving a 1999 Peterbilt semi eastbound on I-94 and hauling a pick-up truck when his vehicle left the roadway and rolled into the ditch, according to the Minnesota State Patrol.

Biggerstaff was not wearing a seat belt or seat restraint at the time of the crash, the State Patrol states. Biggerstaff was pronounced dead at the scene.

I-94 was wet due to a rain passing through the area at the time of the crash.
