# Weathering the storm

### Lakes area ravaged by high winds, rain

## Gale claims life of local fireman

A Blomkest volunteer firefighter was killed Thursday evening as a result of the severe storms that blew through the area that evening.

According to the Kandiyohi County Sheriff's Office, Ryan Erickson, 63, of rural Lake Lillian died after a large grain bin on his property had blown over, collapsing on top of him.

Just before 7 p.m., the sheriff's office received a report of a missing person at the address. Following a brief search, Erickson was found deceased under the bin, and later transported to the Midwest Medical Examiner's Office in Ramsey.

Sheriff Eric Holien said Erickson may have been heading out to conduct storm watch duties when he was struck by the bin, as he was found next to his vehicle. "It looks like he was trying to put the vehicle away to leave," when the bin fell on top of him, Holien told the Review. Although at least two additional storm-related deaths have been reported in South Dakota, no other reports of injuries or deaths occurred in Kandiyohi County, according to Holien.

Born and raised in Willmar and the surrounding area, Erickson's family described him as a "true Blomkest lifer." An active member of the community, Erickson served on the Blomkest Fire Department for over 40 years, as well as various civic organizations including the East Lake Lillian Township Board and Kandiyohi Power Cooperative Board.

## School board selects six superintendent finalists

During a special meeting with the Minnesota School Boards Association Tuesday, The New London-Spicer School Board selected six finalists to interview for the district's superintendent position.

Finalists are:

- Cassie Akerson, Supervisor of Curriculum and Student Programming, St. Michael -Albertville School District;
- Minda Anderson, Assistant Superintendent, Becker School District;
- Jamie Boelter, Principal, New London-Spicer High School;
- Emily McDonald, Assistant Superintendent, Lakeville

Area Public Schools;

- David Pace, Superintendent, Greenway Public Schools;
- Donita Stepan, Superintendent, Thief River Falls Public Schools.

These six finalists were selected from a pool of 12 applicants, with the school board's decision based on recommendations from the MSBA NLS's hiring consultant – as well as the board's own review of candidates' resumes and work references.

Having chosen its finalists, the school board will next conduct two rounds of public interviews. The first initial series will begin at 9 a.m. on May 23, followed by a second, more

in-depth set of interviews beginning at 3 p.m. on May 25. Both will take place in the District Conference Room.

In whittling the candidate pool from 12 to six, each school board member voted on their six preferred candidates, with finalists based on the highest number of collective votes. In keeping with data privacy laws, the school board did not make public which candidates received the highest votes, instead referring to each applicant as "Candidate A," "B," "C," etc.

However, board members discussed at length a variety of factors that influenced their decisions on preferred candidate finalists, including previous career experience, personality, leadership style, skills in technology, finance and communication, and work references. In addition, the board assessed the size of each candidate's district, and potential for longevity.

The board is expected to select its lone finalist on May 25, following the second round of interviews that will take place that day. Contract negotiations will then follow on May 26, with the employment contract approved during the school board's regular meeting on May 31. Contract terms range from one to three years.

If the contract is approved, the new superintendent will begin their term July 1, 2022.

In the event that a contract is not signed between the school board and superintendent candidate, the MSBA will help the district find an interim superintendent for the next school year and initiate another search in January or February

at no cost to the district. Current Superintendent Bill Adams will remain with the district until his contract expires at the end of the present school year. On July 1, 2022, he will join the Willman Public School District, having signed a two-year term as Assistant Superintendent with the potential for advancement.
