Report: Former pastor fired 3 years after alleged abuse

A former youth pastor at a church in Owatonna has been accused of having a relationship with a minor who was part of his youth group.

The case also calls into question the issue of mandatory reporting and has resulted in the resignation of the long-time minister.

Sean Patrick Masopust, 32, of Owatonna, is charged with one felony count of fourth-degree criminal sexual con-

duct. He was arrested at his home last week, then released from custody in lieu of \$5,000 conditional bond. A settlement conference has been set for April 21.

According to the criminal complaint, Masopust initiated a sexual relationship with a girl who worked at the daycare in the church basement - and was also a student youth leader under the direction of Masopust and his wife, who is listed as a "staff member" on the church's website, overseeing the youth ministry.

His father-in-law, Mark Perryman, was listed as the minister of Northridge Church. He resigned Sunday, according to former members of the church.

Masopust's mother-in-law, Tammy Perryman, resigned Friday as the director See CHURCH on A12 ►

Former church youth face off with leadership

Sexual allegations against a former Owatonna youth pastor have resulted in criminal charges and the resignation of the entire ministerial staff-in a case reminiscent of the biblical story of David and Goliath.

The first public whisper of wrong-doing

came on Dec. 21, when Kayla Mollenhauer, a former member of the youth group at Northridge Church, wrote a Facebook post detailing what she called her "religious trauma" at the hands of Felicia and Sean Masopust.

Two months earlier, Sean Masopust had been removed as an associate pastor at the

church, for "conduct unbecoming a pastor," but no details were shared.

In Mollenhauer's post, she described signing a "contract" for the youth group leadership team. It included being prohibited from dating until age 18 and required tithing every paycheck, as well as being "encouraged to tell Felicia everything we knew about" other

members of the group.

Mollenhauer said Mark Perryman, the pastor of the church and Felicia Masopust's father, "berated her" because her mother worked too much "and this was not honoring God. He would tell this to me, a 14-year-old girl, who knows her single mother is just trying to make ends meet.' See FORMER on A10 ▶
