Gabby Petito Case: Look out for those around you

The story of Gabby Petitio and Brian Laundrie has been taking the nation by storm, and speculations and opinions have been shared all over social media. Some believe that the Laundrie parents have some involvement in this case. Some believe that the remains found did not truly belong to Brian Laundrie. This is an ongoing investigation and there seems to be more information every day.

So how can we make a difference here in Wright County? Thousands of miles away from where any of this occurred. Can we prevent something like this from happening in our hometown? Can we learn from this case and do better as a society? A topic that has been

discussed a lot since more information has come out about this case is domestic abuse. There have been many posts on social media shared about young women's self-defense and safety tips, posts that people who are being abused just need to leave their abuser, and signs that someone is abusive and more. Often, a lot of this is geared towards topics to teach your daugh-

One thing you don't see very often is information on how to teach your children how to treat others, specifically in a relationship. For example, you often don't media about teaching young men that hitting or abuse isn't okay. Domestic abuse cases are frequently used as a learning experience for females since females are more likely to get abused.

It's important that we look at these issues from both sides. It is not just on the victims to get themselves out of that situation. It isn't always easy or safe for victims to just leave. It's also not someone's fault that they became a victim of domestic abuse. It's so

important that we teach the younger generations how to control their anger in a healthy way, and that physical abuse or mental abuse is not how you treat a partner; or anyone.

We do not know the full details of the abuse that was going on in Petitio and Laundrie's relationship. All we know is from the body cam footage from when they got pulled over in Utah, after Petitio and Laundrie got into a physical altercation in public. That could have been the only instance, or one of many.

Another huge take away from this case, is if you see abuse or even possible abuse, always report it. If someone goes missing, report it as soon as possible. Share missing persons posts on social media. You could potentially save someone's life. It's better to be safe than sorry.

According to Kare 11 News, last year 30 individuals lost their lives to intimate partner homicide in Minnesota alone. As we saw in the Utah body cam foot-age of Petitio and Laundrie, law enforcement officers had received a call earlier that there was a domestic dispute between the two. Law enforcement ended up separating the couple for the night.

It's also important to remember that this is not meant to be entertainment. Two young lives were lost in this case. Two families are grieving, friends of both individuals are grieving. It is a tremendously tragic occurrence. Those close to Petito and Laundrie have been dealing with the aftermath of this for a few months now. Showing respect and praying for those involved is just one way to make a positive impact on a currently very dark situation.
