Allina Health changes policy to allow additional visitors; masking and social distancing still required

Health has changed its visitor policy guidelines allowing for additional family and friends to visit patients. Safety measures including masking and social distancing still remain in place, to keep our patients, staff and visitors safe.

All visitors and support persons will continue to be screened for symptoms consistent with COVID-19. Visitors or support persons who do not pass the screening will not be able to visit or accompany a patient in clinic and hospital settings.

For most inpatients, the policy changes mean there is no specific limit on the number of visitors as long as they pass the COVID-19 screening and safe social

distancing is possible. Children ages 5 - 17 must be from the same household as the patient in order to visit and must be accompanied by an adult visitor.

In our birth centers, two support people are allowed per patient during triage, labor and delivery. In ante-partum and post-partum areas up to two minors ages 5-17 from the same household are allowed, in addition to the two support

Complete visitor guide-lines for other service areas of our hospitals can be viewed online.

At times, the number of visitors in a patient's room may need to be limited out of medical necessity, as determined by the care team.

Public Health releases weekly COVID-19 dashboard

Wright County Public gan, there have been 36,417 Health has released its COVID-19 dashboard for the period of March 18-24 and, for second straight week, the number of new cases over that seven-day period was the lowest since July 2021.

There were just 33 new confirmed cases over the last seven days. In addition, there were seven cases that required hospitalization, four cases that required treatment in an Intensive Care Unit and no deaths. Since the pandemic beconfirmed cases in Wright County, 1,473 cases that required hospitalization, 252 that required a stay in an ICU and 304 deaths. To see the full dashboard,

Finan shared, "I think it is well managed. My concern as a citizen is focused on climate change and how we're going to achieve energy security and supply for the globe moving forward... I am very concerned with health and safety in general, but I also know advanced nuclear is very safe. Today's nuclear is very safe. It is the safest form of energy we have.'

I echo Finan's sentiments on the importance of nuclear energy. As Minnesota works to find affordable, clean, renewable sources of energy, it is critical to keep all options on the table.

In 2020, Minnesota's two nuclear power plants, Prairie Island and Monticello, safely fueled 26% of the state's electricity net generation, while emitting no greenhouse gases. For this reason, I am au-

thoring a bill to fully repeal our state's ban on the construction of new nuclear power facilities in Minnesota, which has been in effect for over two decades. My proposal does not mandate building any new plants, but instead allows power companies to consider all options.

Therefore, I strongly believe we need low-carbon electricity that is not dependent on the weather or wind and our nuclear power plants provide just that.
