So, who cares about primary elections?

With lively State Senate, Otter Tail County board primary elections; voters will be paying attention to Aug. 9 results

The message for Election Year 2022?

Don't "yawn" your way through the August primary election—there are important decisions at the primary

Historically, primary election turnout is dismal—compared to the November general election. There's usually a good reason for the poor turnout: There's rarely a local or area primary race of interest to voters.

But the August 9 primary election this year is commanding our attention, especially in Otter Tail County.

Two Republicans are running for the newly-drawn State Senate District 9 seat. One-term State House legislator Jordan Rasmusson, endorsed earlier this year by the Republican party, is being challenged by Nathan Miller, a hobby farmer, certified boiler operator, and political newcomer.

Based on the action—and reaction—along summer parade routes, the Miller-Rasmsusson primary election could inspire a record primary turnout in this area.

Miller is the guy in the red-white-blue shirt, western hat, and the handgun on his hip. The Miller crew and large squad of volunteers joined in group prayer sessions prior to the Erhard July 4th parade, and Miller's Christian faith is front and center in his campaign.

Meanwhile, Rasmusson was elected to the House in 2020, but in his short time in office, he's gained a reputation for effectively representing the interests of his district—which includes Pelican Rapids, Fergus Falls, and much of the Otter Tail lakes area.

Very likely, Rasmusson would have been happy serving the area for another term in the State House—but State Senator Bill Ingebrigtsen retired. Combined with re-districting, which created an immense State Senate 9 district, from the lakes area to the North Dakota border, it was logical that Rasmusson would step up and run for State Senate.

A shoo-in during a "normal" political climate, Rasmusson instead finds himself challenged within his own party. While Miller has not, to our knowledge, publicly touted President Donald Trump connections, his campaign can be described as "Trump-inspired" and supported by a large contingent of volunteers of the "Trump populist" mold.

Both opponents have hit the campaign trail hard and fast—fully aware that making it through the August 9 primary is the prize.

Whoever wins will face Democrat Cornell Walker in the November general election. While Senate District 9 is mostly Republican territory, Walker's resume is intriguing for many voters. The fact that Walker is about twice the age of either of the Republicans may, or may not, gather him a few votes.

DFL-endorsed Walker is an Army veteran with a law degree, and 40 years of experience as a trial lawyer and mediator. Walker fashions himself as a bipartisan prob-

With regional Republicans having a few problems of their own, culminating in an aggressive primary campaign ahead of August 9—a November general election victory could be more problematic than Republicans imagined.

Five candidates are running for the Otter Tail County board District 2 seat, adding a local dose of intrigue for the August 9 primary.


The two top vote-getters will continue on in the November general election.

All teachers expecting to teach the coming year and whose certificates expire August 1, 1922, must make an application for renewal or exchange at this time. All beginning candidates who have not had the required professional training must pass the examination in all second grade subjects unless covered by a standardized credit from a Minnesota State Teachers College or an acceptable High School Board credit.

In the first game, Pelican was defeated by Perham 9 to 7, but this game was forfeited on account of Perham having three players over the age limit. In the second game, Pelican played New York Mills and easily won 19 to 8.

50 years ago, July 20, 1972

 Man Overcome by Smoke in Fire Saturday at His Home

A Pelican Lake man was hospitalized here for smoke inhalation after fire damaged his home early Saturday.

Bill Eggermont, who lives near Goslee Beach on Pelican Lake, was hospitalized at the Pelican Valley Health Center after he was overcome by smoke while attempting to confine a fire that broke out in his home at about 4 a.m. Saturday. He has since been released from the hospital.

The fire apparently started at an electrical outlet in the kitchen of the home and spread into the wall. Eggermont was awakened by the smoke and roused his wife and family to clear the house. He went back into the house, however, using a garden hose to confine the fire until the volunteer fire department arrived at the scene.

Eggermont was administered oxygen by firemen, but when he did not respond, he was taken to the hospital by Ted Hornbacher, Fargo, who lives nearby at the lake. Hornbacher owns the home in which the Eggermont family

Fire Department spokesmen said that damage was confined mainly to the one wall in the kitchen. The house had been re-wired and remodeled last year, a fireman reported. • Arson Blamed in Two Fires

Arson is suspected in the burning of two abandoned farmhouses in the past few days, according to the Pelican Rapids Fire Chief Rex Crews.

The two houses that burned were within a few hundred yards of each other and were located between the northeast end of Pelican Lake and Highway 59. The fire department here was called at about 1:45 a.m. Saturday for the first fire and at about 10:30 p.m. Monday for the second.

The building that burned Saturday morning was of frame construction. The old house that burned Monday night was of log construction. According to one of the fire department members, the Audubon fire department had been at the scene earlier Monday and had confined the fire, leaving the logs to burn. The Pelican Rapids department was called later when someone noticed it still burning.

The property is reportedly owned by Howard Olson, but this was still being verified by the department.

Chief Rex Crews reported Tuesday that a state fire marshall has been contacted to investigate the fires.


