City should get off residents' lawns

Leaving Jackson for two weeks to tend to a family matter left me split away from the city I've called home for 15 years. Thankfully, the Internet allows us to connect instantly to those in distant places, so I was able to follow goings on in town from the mountains of upstate New York and the traffic-clogged streets of eastern Pennsylvania.

A little kerfuffle arose that, while not a big deal in and of itself, is illustrative of government excess, even at the local level. The city of Jackson reminded the public of a lawn ordinance on its Facebook page, stating grass must not exceed 6 inches in height. Failure to comply will result in a mowing notice, with the possibility of a \$145 fee to have the city cut one's grass.

Whatever you think of a person's motivations in mowing his or her lawn

or not, the simple fact is the city has no place in regulating how high a lawn's grass can be.

When someone

purchases a house — or any piece of property he or she is taking a significant financial risk and should be able to enjoy the rewards of that risk, so long as he or she does not directly harm others. If I decide not to mow my lawn, I'm not harming anyone - my neighbor can mow his lawn as he wishes. Sure, my neighbor might not like how my yard looks, but he might not like any number of things about me - how I dress, whether I have a beard or not, the color of my house and so on. Should I let him determine these things also?

The reason why these ordinances exist is plainly obvious; they make money for the city and mollify busybodies.

When can one be rightly compelled to mow one's lawn? Two scenarios come to mind. First, a person may enter into contract with his or her neighbors regarding grass length, signing an agreement among them to keep grass cut and, second, a tenant may be required to keep grass cut as part of a rental arrangement. government — at all levels — when it asks for too much and delivers too little. So many areas of life — even how long your grass can be — are regulated unnecessarily. The city should abolish its lawn ordinance and any similar ordinances on the books. They serve no purpose except to harass residents, shovel

undeserved money to the city and create unnecessary work for everyone.

An ordinance that violates personal liberty and private property rights and harms the environment at the same time is not worth keeping. The city should focus on getting its construction projects done in a timely manner and trying to attract more young people to Jackson rather than bothering people over grass length.

new three-digit phone number

Question: I recently heard something about a new phone number — 988 for people dealing with a mental health crisis. With all these three-digit numbers — 911, 411, 511 can you provide some insight?

Answer: The number 988 has been designated as the new threedigit dialing code that will route callers to the National Suicide Prevention Lifeline. While some areas may be currently able to connect to the Lifeline by dialing 988, this dialing code will be available to everyone across the United States

starting on July 16.

When people call, text or chat 988, they will be connected to trained counselors who are part of the existing National Suicide Prevention Lifeline network. These trained counselors will listen, understand how their problems are affecting them, provide support and connect them to resources if necessary.

The current Lifeline phone number — 1-800-273-8255 — will always remain available to people in emotional distress or suicidal crisis, even after 988 is launched nationally.

The Lifeline's network of more than 180 crisis centers has been in operation since 2005 and has been proven to be effective. It's the counselors at these local crisis centers who answer the contacts the Lifeline receives every day. Numerous studies have shown callers feel less suicidal, less depressed, less overwhelmed and more hopeful after speaking with a Lifeline counselor.
