# Former mayor plans petition to force exit of Robbinsdale councilmember

The fallout of a drunk driving arrest of a Robbinsdale City Councilmember now includes a citizen petition to force his removal from office. Former Robbinsdale Mayor Regan Murphy has announced he is leading an effort to get Tyler Kline removed from his Ward 1 council seat.

On Feb. 15, Murphy addressed the Robbinsdale City Council during an open forum to discuss his next steps, calling Kline's Jan. 24 arrest "an undeniable breach of trust" to the Robbinsdale community.

During the first hours of Jan. 24, Kline allegedly caused a traffic crash driving while traveling the wrong way on Highway 100 in his vehicle. He reportedly evaded police multiple times across city boundaries until his car was ultimately forced to a stop after a police squad car drove into him. According to the police report, after refusing to obey commands, Kline was then physically removed from his vehicle where he was found to have a blood alcohol concentration of 0.20.

Kline has since enrolled himself in a day treatment program and has announced his plans to stay on the

To date, two current Robbinsdale City Councilmembers have asked Kline to step down, and two have said they will not offer their opinion on the matter on the basis that the decision is up to Kline and his voters

# **Redistricting alters Senate District 46 map**

A redistricting map shows that Sen. Ron Latz (DFL-St. Louis Park) will live in the same senate district as a Senate Minority Leader Melisa López Franzen (DFL-Edina), but Latz said he still plans to run for re-election.

The map that a state court panel released Feb. 15 shifts Senate District 46 to the south, keeping St. Louis Park and Hopkins but adding

part of Edina while removing sections of Golden Valley, Plymouth and Medicine Lake.

That creates an electoral conundrum, with López Franzen - who lives in Edina and has represented Senate District 49 – residing in the same area.

The Latz for Senate Volunteer Committee released a statement I am elated to maintain nearly 80 that says Latz "confirmed his commitment to run for the Minnesota State Senate in the newly drawn Senate District 46.'

Latz, a St. Louis Park resident, added that he is proud to have represented the cities that will no longer be in his district for the last decade.

"I will miss representing these great communities," Latz said of Golden Valley, Plymouth and Medicine Lake. "This is the unfortunate nature of redistricting. Fortunately, percent of the previous District 46 in the newly formed District 46,

A panel appointed by the Minnesota Judicial Branch unveiled congressional and legislative redistricting plans last week restructuring the boundaries of state and national political offices in the state until the next Census in

The data was required by law to be published 25 weeks before the state primary election, Feb. 15.

## **Changes to District 45**

According to the plan, all of the area covered by Senate District 45 will become Senate District 43 in the next election cycle.

In general, drawn within the boundaries of the new Senate District 43 are the entire cities of Crystal, Golden Valley, New Hope, and Robbinsdale, with some portions of Plym-

outh. The newly-drawn district will now represent all of the city of Golden Valley. Previously, Golden Valley's three southernmost precincts, precincts 3, 5 and 8, shared legislative representation with St. Louis Park in District 46.

The portions of Plymouth represented in the new district are also different. According to the redistricting plan, District 43 will swap representation of the city's northeastern 19, 22, and 23 precincts for precincts 16 and 17 to the southeast.

For the last decade, Senate District 45 has encompassed all of Crystal, New Hope, Robbinsdale, northern Golden Valley and northeastern Plymouth. The district is represented by Sen. Ann Rest.

In a conversation with the Sun Post, Kline said that he was aware of a group that was opposed to him remaining on the council, and the recall process was "totally their right" to pursue.

"That's their views, and that's okay," said Kline. "I'd hope more people have room for me bettering myself while continuing to do good for the community." Kline said if the petition

gathered enough signatures, he had not decided whether he would run in the special election.

"That would be something I'd have to talk about with my family and neighbors," Kline said.

The latest incident is the second time Kline has been charged for drinking and driving. According to court records, in 2010 Kline was charged with driving under the influence, as well as careless driving and failing to yield to an emergency vehicle. The charges for the DUI were dismissed one year later.

According to city charter, a felony conviction is also grounds for a councilmember's removal from office in Robbinsdale. While Kline has been charged with a felony, he has not yet been convicted.
